## Data privacy statement

I agree that the Franken Knights e.V., as the responsible body, processes and uses the personal data collected in the declaration of accession, such as last name, first name, date of birth, address, e-mail address, telephone number and bank details exclusively for the purposes of member administration, the collection of membership fees and the transmission of association information by the association.

A transmission of parts of this data to the respective sports associations and the Bayerischen Landes-Sportverband e.V. (BLSV) only takes place within the framework of the rules and regulations laid down in the statutes of the professional associations or of the BLSV.
